# GENERAL TERMS AND CONDITIONS OF SALE OF GOLAZO SPORTS NV

# 1. SCOPE OF APPLICATION

These general terms and conditions apply to all deliveries made and all services performed by Golazo Sports NV, with the exception of written deviations and without prejudice to any special conditions agreed in a separate contract. The client declares to have read and accepted these general conditions. These conditions take precedence over any general or extraordinary conditions of the client.

#### 2. ORDER - OFFER

Only an offer made in writing by Golazo Sports NV is valid. The validity of the offer is limited to 30 days. The contract is only concluded after Golazo sports NV has accepted the client's order.

#### 3. REPRESENTATION

The client is validly represented by the signatory of the order form.

#### 4. INTELLECTUAL RIGHTS - PROPERTY

Golazo Sports NV remains the sole holder of the intellectual property rights of its creations and organisations. Any delivery remains the property of Golazo Sports NV until full payment of the price.

#### PRICE

The prices invoiced by Golazo Sports NV are shown in Euro, excluding taxes. The exchange risk is borne by the client.

#### 6. PERIOD OF EXECUTION

Only the periods indicated in writing by Golazo Sports NV are binding. These deadlines shall in any case be extended in the event of (1) force majeure (2) modification of the order by client (3) delay in the transmission of information and/or documents by the client (4) delay in payment.

#### 7. TERMS OF EXECUTION

The transport risk and postage and delivery costs shall be borne exclusively by the client.

#### 8. PAYMENT - LATE PAYMENT

Invoices from Golazo Sports NV must be paid in cash. The invoices must be paid at the registered office of Golazo Sports NV. Invoices are payable within 30 days. When tickets and VIP tickets are purchased, they will not be sent to the client until full payment has been received by Golazo Sports NV. If payment is not made by the due day, the amount of each invoice issued by Golazo Sports NV will be increased by law and without prior notice of default by a conventional fixed and irreducible compensation of 10 % and interest at the rate of 1% per month of arrears.

# 9. CANCELLATION OF THE ORDER

The contract cannot be cancelled by the client. If extraordinary circumstances prevent the client from doing so, the client may request cancellation by written request to Golazo Sports NV, subject to payment of the following cancellation fees depending on the time of cancellation, without prejudice to Golazo Sports NV's right to claim damages insofar as the cancellation fees are insufficient:

- within 120 days before the start of the event: 50 % of the amounts due by the client
- within 60 days before the start of the event: 75 % of the amounts due by the client
- within 30 days before the start of the event: 100 % of the amounts due by the client
- one day before the start of the event: 150 % of the amount due by the client

Golazo Sports NV will send the client written confirmation of the cancellation in case of acceptance of the extraordinary circumstances of prevention, which will be assessed autonomously by Golazo Sports.

# 10. FORCE MAJEURE - CANCELLATION OF THE EVENT

Golazo Sports NV is only liable for a shortcoming attributable to it, insofar as the liability is not expressly excluded or limited in these general conditions. The total liability of Golazo Sports NV is in any case limited to compensation for direct damage (excluding indirect damage) and can never exceed the value of the sums paid by the client. Liability in the event of force majeure is excluded. Force majeure means any circumstance beyond the control of Golazo Sports NV, which prevents it (even temporarily) from fulfilling its obligations in full or in part. This includes (non-exhaustive), instructions, decisions or interventions of any kind by public, administrative or regulatory services ("fait du Prince"), terrorism or threat of terror, extreme weather conditions (such as extreme heat, thunderstorms, storms, squalls, floods, etc.), fire, riots, war or threat of war, insurrection, epidemic, pandemic (such as COVID-19), state of quarantine, breakdowns in a (telecommunications) network or connection or communication systems used, disturbances on public roads, blockades, strikes or lock-outs, demonstrations and other disruptive interference. In the event that, due to force majeure, the event cannot take place at the planned location or on the planned date, or cannot take place in part or at all, Golazo Sports NV may decide to change the location or move it to a later date, or limit the duration of the event, or adjust the format of the event or cancel the event altogether. In these circumstances, the client acknowledges that they are not entitled to any refund of amounts paid, compensation or expenses. The client's order will then be automatically transferred to the new date of the (modified) event or to the next edition of the event. In the event of cancellation of the event by Golazo Sports NV outside cases of force majeure, Golazo Sports NV will refund to the client a portion of the amounts paid, to be determined in fairness and reasonableness. Such reimbursement by Golazo Sports NV, if awarded, will in any case never exceed the amount paid by the client. Any other costs incurred, such as service and administration costs and any extras, will not be refunded.

### 11. COVID-19

COVID-19 is a highly contagious disease that can lead to serious illness and death. An inherent risk of exposure to COVID-19 exists in any public place where people are present. Attendance at the event is entirely voluntary and at the client's own risk and constitutes acceptance of the risks related to exposure to COVID-19. Golazo Sport NV is not liable in the event of contracting contamination from COVID-19.

# 12. SOLIDARITY

In case of multiple clients, they are jointly and severally liable for their various obligations and are deemed to have waived the advantages of division and dispute.

# 13. COMPLAINTS

No complaint will be accepted if it is not addressed to Golazo Sports NV by registered letter within 8 days of the execution of the contract.

# 14. OBLIGATIONS

Golazo Sports NV makes every effort to fulfil its contractual obligations and the expectations of the client. However, it can only be bound by an obligation of means.

# 15. JURISDICTION AND APPLICABLE LAW.

Only the courts and tribunals of the jurisdiction where Golazo Sports NV's registered office is located have jurisdiction. Belgian law is applicable.
